**COMUNICATES** the opening of the Selection Process for foreign students not residing in Brazil to enter the Graduate Program in Education - Master's and PhD - Continuous Flow, WITHOUT SCHOLARSHIP modality, as follows:

#### NUMBER OF VACANCIES:

Master's: 4 (four) annual vacancies (Two for the first semester and two for the second semester).

PhD: 4 (four) annual vacancies (Two for the first semester and two for the second semester).





#### **REGULATION:**

#### Title I – General Rules

**Art. 1** - Registrations for the Selection Process to **foreign students not residing in Brazil** for admission to the Graduate Program in Education - Master's and PhD - **Continuous Flow**, WITHOUT SCHOLARSHIP modality, - will be open during the period set out in the schedule of this notice.

**Art. 2** - The selection process for admission to the PPE will be organized in an integrated manner by field of research, respecting the number of vacancies available in the PPE and approved at a meeting of the Interdepartmental Council.

Art. 3 - The selection process will comprise two phases:

I – Analysis of the Dissertation/Thesis Project;

II – Defense of the Dissertation/Thesis Project in a qualifying interview.

**Single §** - A model for the preparation of the Dissertation/Thesis Project can be found attached to this Notice.

Art. 4 – Regarding the evaluation of the dissertation/thesis project in an interview:

I – The Dissertation/Thesis Project will be evaluated according to the following criteria:

- a) Relevance of the Dissertation/Thesis Project to the field of research applied;
- b) Formal aspects of the project in accordance with the proposed model and technical presentation standards;
- c) Clear, coherent structure and precise language;
- d) Relevance and suitability of the theoretical-methodological proposal to the object of study of the Dissertation/Thesis Project;
- e) Objectives and justifications that demonstrate the relevance of the project;
- f) Project development feasibility;
- g) Proficiency in the content and references presented.

**Art. 5** - The grade for the evaluation of the Dissertation/Thesis Project in an interview, on a scale from 0 (zero) to 10 (ten), will result from the simple arithmetic average of the grades of each member of the Committee, with two decimal places and decimal approximation.

**Art. 6** - To be considered successful in the Selection Process, the candidate must obtain a final grade equal to or greater than 7.00 (seven point zero) and rank within the limit of vacancies offered by the Program.

§ 1 - The final grades will be approved by the PPE's Academic Council.

§ 2 - In the event of a tie in the final score, the following tie-breaking criteria will be used:

I – candidates who have already been granted a scholarship by their country of origin to study for a Master's/PhD;

II – longer professional experience as a teacher in higher education and/or basic education [attach proof(s) to the Curriculum Vitae];





III – oldest candidate;

**Art. 7** - The Selection Committee will be proposed by the respective Field of Research and approved by the PPE's Academic Council.

### Title II – Required documents for registration

**Art. 8** - When registering, candidates must send the following documents to the following e-mail address <u>sec-ppe@uem.br</u> (Subject of the e-mail: "FOREIGN SELECTION - Continuous Flow"; Provide in the email content: Full Name and Project Title):

a) Photocopy of graduation diploma (front and back);

b) Photocopy of Undergraduate Transcript;

c) Photocopy of Passport;

d) Proof of address;

e) Dissertation/Thesis Project according to the script available in Attachment I of this Notice;

f) Curriculum Vitae (preferably in the Lattes/CNPq model duly updated - Attach ONLY proof of professional experience as a teacher in higher education and/or basic education); § 1 – Foreign candidates must provide documentation of their residence in Brazil if they pass the selection process, at the time of enrollment, in accordance with Resolution No. 92/94-CEP;

### Title III – Final consideration

Art. 9 – Omissions will be settled by the PPE's Academic Council.

**Single Paragraph** – By registering, the candidate accepts the conditions and rules established by this Notice.
